

### It's Been a Hard Year

We all remember easier times. Though it might feel impossibly long ago, our students, teachers, artists, communities, and *you* remember times that felt **safer**, **freer**, **and simpler** than these.

But in the face of 2020's many challenges, CAPE is so proud of the work our partners and staff members have accomplished and the ways in which we've been able to sustain and expand support for our schools and creative communities. Since closures began in March, CAPE has:

- Committed to paying teaching artists for the months they'd expected to be in classrooms
- Created and delivered art supply kits to families across the Chicago
- <u>Built a vast library of video lessons</u> taught by partner teachers and teaching artists
- <u>Launched the CAPE Network Forum</u>, a site for partners to share work, celebrate success, and seek support from their peers
- Hosted more than two dozen free training sessions for the general public and CAPE partners to help them better adapt to remote teaching, learning, and art making

We **never** halted our programs. We never dialed back our dedication to making classroomstraditional or virtual-places of inspiration and self-discovery for students *and* their educators. And we never stopped working to make 2020 feel a little safer, a little freer, a little simpler for everyone in CAPE's programs.







